Update: (Re)Imagine

Rachel updated work group over phone:

Update: Stupski Task Force

Christine updated work group about quantitative/qualitative testing process delivered by RAND Corp. which will test residents' via "cognitive interviewing." Data will include people who passed away within 2-6 month timeframe from dementia, etc. The first round of testing will be in English using informed/verbal consent. Once successful, testing will be followed up in Chinese and Spanish. Participants would receive cash payments.

Feedback: Program Manager job description and request for applications

Christine emphasized budget vs. the expectations for submitted proposal.** For example, in regards to contract and salary of the position, group settled that payment based on deliverables rather than hourly rate is desired. Project Manager is to review strategic plan and develop a business plan within a year and six months. Deadline projected for Friday, December 15, 2017.
